Mr. Murray focuses his practice on securing and administering patents for clients in many technology industries, including mechanical and electrical devices, optics (including devices such as lasers, barcode scanners, imagers and portable data terminals), the semiconductor or solid-state field (including semiconductor manufacturing and computer memory), and in video gaming, such as arcade machines and programming. He has further successfully assisted clients in inter partes reviews and reexaminations in these same industries, and has conducted oral argument before the PTAB in a number of those cases.

Mr. Murray earned his B.S. summa cum laude in physics from Temple University. He received the Otto Kurschner Award for Excellence in Science, given to the member of the graduating class concentrating in biology, biochemistry, geology or physics who attains the highest scholastic average. He received his J.D. from the Temple University Beasley School of Law.

Mr. Murray is registered to practice before the U.S. Patent & Trademark Office, is a member of the Pennsylvania and New Jersey Bars, and is admitted to practice before the U.S. Supreme Court, the U.S. Court of Appeals for the Federal Circuit, and the U.S. District Courts for the Eastern District of Pennsylvania and the District of New Jersey. 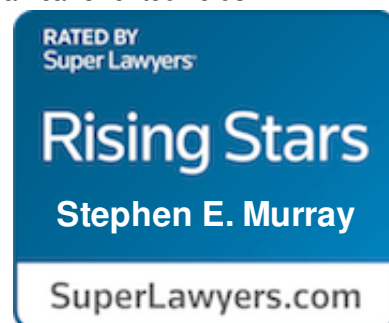
