Rich Intellectual Property Moot Court Team, winning second place in briefs at the regional competition, and where she also won the John J. Mackiewicz Memorial Scholarship in Intellectual Property. She is a member of the Pennsylvania and New Jersey Bars and is admitted to practice before the United States Patent and Trademark Office.

Dr. Hsing is an inventor of biotechnology inventions. She has published various research papers in leading scientific journals including Science and Nature. She is an Executive Council Member of Sino-American Pharmaceutical Professionals Association (Greater Philadelphia) and a BayHelix member.
