#### **Oracle v. Google – Update** // January 29, 2019

*Oracle America, Inc. v. Google LLC* is a series of related intellectual property law cases making its way through the courts for almost a decade, with the latest decision issued by the U.S. Court of Appeals for the Federal Circuit in the spring of 2018, and discussed in our previous article published on June 14, 2018. *Oracle America, Inc. v. Google LLC* has been dubbed “the World Series of IP cases” by one of the presiding judges. Others have referred to the dispute as the case that never ends.
